ANTIGUA & BARBUDA CITIZENSHIP BY INVESTMENT

The Antigua & Barbuda Citizenship by Investment program gives foreign individuals the opportunity to obtain citizenship and a second passport by making an investment in the country with a quick processing time.

PROGRAM OVERVIEW

4-6 months to citizenship

5 days residency required in a 5 year period

No language requirements

Dual citizenship is permitted

Include spouse, dependent children under 30 years of age, dependent parents and grandparents over 55 years of age, and unmarried siblings.

Zero tax on worldwide income





INVESTMENT CRITERIA

Antigua & Barbuda's Citizenship by Investment Program (CIP) was passed into law in 2014 as part of the Citizenship by Investment Act. To qualify, the primary applicant must select one of the following three investment options;

OPTION 1

NATIONAL DEVELOPMENT FUND (NDF)

Minimum Investment - \$230,000 USD

Investors under this option are required to make a non-refundable payment of \$230,000 to the NDF.

OPTION 2

UNIVERSITY OF WEST INDIES (UWI) FUND

Minimum Investment - \$260,000 USD

A family of six or more under this option may receive citizenship through a minimum investment of \$260,000 into the UWI Fund.

OPTION 3

APPROVED REAL ESTATE INVESTMENT

Minimum Investment - \$300,000 USD

A minimum investment of \$300,000 USD or \$200,000 each by two related parties is required into one of the CBI approved projects.

OPTION 4

BUSINESS ESTABLISHMENT

Minimum Investment - \$400,000 USD

Investors receive citizenship following the investment of \$1.5 million USD into an approved business. Each investor is required to contribute at least \$400,000 with a total of \$5 million USD.

PROCESSING FEES

- \$30,000 for a family of 4 persons (Option 1)
- \$50,000 for a family of 4 persons (Option 3 & 4)
- \$15,000 for each additional dependent above the family of 4 (Option 1, 3 & 4)
- \$15,000 for each additional dependent above the family of 6 (Option 2)
- \$50,000 for each sibling.

- \$300 / person Bank Fee
- \$1,500 interview fee
