SPAIN DIGITAL NOMAD VISA

Spain offers two attractive residency options for non-EU nationals seeking to live in one of Europe's most dynamic and culturally rich countries.

Both programmes allow foreign applicants and their families to reside legally in Spain, enjoy visa-free travel across the Schengen Zone, and benefit from the country's high quality of life, healthcare, and education systems. In addition, applicants are able to travel visa free to the 29 Schengen member countries including Germany, France and Switzerland.

PROGRAM OVERVIEW

Visa-free travel within the 29 Schengen member states

Applicants qualify for permanent residency with at least 6 months per year in the first five years

Applicants can include his/her spouse and dependent children

Special tax rate for Nomads allows you to pay flat tax rate (24%) on income instead of progressive rate (up to 48%)

After 10 years of residency in Spain, you may qualify for citizenship





DIGITAL NOMAD VISA

The programme is designed for remote workers and freelancers from outside the EU who are either self-employed or who are employed by a company outside of Spain, with the intent to relocate to Spain.

Applicants to this programme must:

- Have been working for the foreign company or clients for at least 3 months prior to the application.
- Have a contract with the foreign company or clients that extends at least 1 year into the future.
- Demonstrate 3 years of work-related experience or a degree from a reputable institution.
- Have no criminal records or entry ban to Spain.
- Obtain private health insurance with full coverage in Spain.
- Have a minimum income of €34,000 / year for a Single Application. An additional €13,000 / year for the first additional family member, and €5,000 / year for each additional applicant.

The freelancer must:

- Work with at least one foreign company.
- The foreign company must have been operating for at least 1 year prior to the application.
- Prove that the foreign company allows them to work remotely in Spain.

APPLICATION FEES

Elevay provides a complete package for the initial application for residency. The cost of this package is €10,000 for a single applicant and the fees will change based on the family size. This covers all associated fees and services, but does not include your lease and health insurance.

RENEWALS

The duration of the initial residency permit is 3 years, after which, it must be renewed for 2 years until you receive permanent residency. The associated fees for renewals or application for permanent residency can be provided upon request.

• NON-LUCRATIVE VISA

Applicants to this programme must:

- Be non-EU / EEA / Swiss citizens.
- Have no criminal record and no entry ban to Spain or the Schengen Area.
- Obtain private health insurance with full coverage in Spain.
- Demonstrate stable and sufficient income or savings to sustain living expenses without local employment.
- Provide proof of accommodation in Spain (property ownership or long-term rental agreement).

Financial Requirements:

- Minimum annual income of approximately €28,800 for the main applicant.
- An additional €7,200 per year for each dependent family member.
- Proof of funds can include pension statements, investment income, or bank savings.

Validity and Renewal:

- The initial residence permit is issued for one year, renewable for two-year periods thereafter.
- After five years of continuous residence, holders become eligible for permanent residency.
- Applicants must reside in Spain for at least 183 days per year to maintain their residency status.

APPLICATION FEES
