ST. KITTS & NEVIS CITIZENSHIP BY INVESTMENT

The St. Kitts and Nevis Citizenship by Investment Programme is the longest running and most-trusted program of its kind. Having been in operation for over 20 years, they have refined the process of getting a second citizenship and a passport.

INVESTMENT CRITERIA

The investor programme in St. Kitts and Nevis seeks to attract foreign individuals who will be entitled to obtain St. Kitts and Nevis citizenship and passport in a period of approximately 6-9 months, upon making one of the following investment options:

OPTION 1 - SUSTAINABLE ISLAND STATE CONTRIBUTION **Minimum Investment - \$250,000**

This option involves making a non-refundable payment to the Sustainable Island State Contribution. Payment depends on the number of family members included.

OPTION 2 - APPROVED REAL ESTATE INVESTMENT **Minimum Investment - \$325,000**

Applicants may invest in approved developments at a minimum investment of \$325,000, resellable after 7 years.

OPTION 3 - PRIVATE REAL ESTATE INVESTMENT **Minimum Investment - \$325,000**

Applicants may apply for citizenship by investment by purchasing either a condominium unit or share in real estate development for a minimum of \$325,000 USD or a single-family private dwelling home for a minimum of \$600,000 USD. The real estate must be held for 7 years.

OPTION 4 - APPROVED PUBLIC BENEFIT PROJECT **Minimum Investment - \$250,000**

A minimum investment per application of \$250,000 must be made in an Approved Public Good Investment, payable to an Approved Public Good Investor.

GOVERNMENT FEES (OPTIONS 2, 3, AND 4)

- \$25,000 for main applicant (Exempt on Option 4)
- \$15,000 for spouse
- \$10,000 for each dependent child under 18.
- \$15,000 for dependent aged 18+

OTHER FEES

- \$250 / person Application Fee
- \$500 / person Passport Fee
- \$50 / person Certificate of Registration

BANK FEES

- \$200 for main applicant
- \$100 for 16 years and over
- \$50 each child 10-15 years

DUE DILIGENCE FEE

Main applicant	\$10,000
Spouse	\$7,500
Dependents 16+	\$7,500 each
Dependent parents	\$7,500 each

REAL ESTATE CLOSING COSTS

- 1.5% of the property value paid as a legal fee after approval.
