The Representative of Overseas Business Visa program gives overseas companies a route to establish a commercial presence in the UK. This is a great opportunity to test the UK and European markets by sending a representative to establish and operate a registered branch or wholly-owned subsidiary. Unlike the Tier 1 Visa, there are no requirements for minimum investment, job creation or profitability.

PROGRAM OVERVIEW

Approval time as low as 3 months.

Spouse and dependent children under 18 years of age can be included. May not include dependent parents.

Must reside for 6 months per year in the UK to be eligible for permanent residency. To be eligible for citizenship, must reside 9 months per year in the UK.

Eligible for citizenship after 6 years of residency.

Visa-free travel to 160 countries after obtaining citizenship.

Dual citizenship is permitted

Required language skill of IELTS band score of at least 4.







REPRESENTATIVE OF AN OVERSEAS BUSINESS VISA PROGRAM

This program allows a senior employee of an overseas company to gain residency in the United Kingdom for the purpose of establishing a commercial presence in the UK or Europe. The UK company may be either a registered branch or a wholly owned subsidiary of the parent company.

Note:

All application fees by the Government of the United Kingdom and M&E are subject to change. These fees depend on the number of applicants and the complexity of the process

ELIGIBILITY

Representative must be recruited and employed outside of the UK by the company which they intend to represent in the UK and have been employed for at least six months.

The employee must hold a senior position in the organization.

The sole representative should not have a shareholdings of more than 20%.

The employee must be able to support themselves without help from public funds. This means they should have a minimum salary of £25,000.

The UK company must be a registered branch or wholly owned subsidiary of the foreign company.

Ideally, the company will already be doing business in the UK or Europe. As part of the application, you will need to justify why the company wants to set up business in the UK.

Must be the first commercial presence in the UK. The parent company must not have any branch, subsidiary or other representative in the UK.

The employee must meet the English language requirement - IELTS band score of at least 4.

FEES

The following fees must be paid as part of the application process for the initial 3 year visa:

VISA FEES

• £610 per person

IMMIGRATION HEALTH SURCHAGE FEES

• £400 per person - per year - for 3 years (£1,200 total)

PRIORITY SERVICE

• £220 per person (optional)

PROFESSIONAL FEES

• Provided upon request.

PROCESS

The following outlines the process in making your application through to obtaining citizenship (optional):



STAGE ONE:

INITIAL VISA - 3 YEARS

The first step is to submit an application and required documents. At this time all required fees must be paid. After 3 months processing, successful applicants and their dependents will receive their initial visa for a three year period.



STAGE TWO:

VISA RENEWAL - 2 YEAR EXTENSION

The initial visa expires after three years. It is at this time, that you will be required to renew the visa for a two year extension.



STAGE THREE:

PERMANENT RESIDENCY AFTER 5 YEARS

Following five years as a resident, the sole representative and dependents are able to apply for permission to settle permanently in the UK (permanent residency).



STAGE FOUR: CITIZENSHIP (OPTIONAL)

Following one year as a permanent resident - six years total - the representative and dependents may be eligible for citizenship.
