## NAURU CITIZENSHIP BY INVESTMENT

The Nauru \*Economic and Climate Resilience Citizenship Program (ECRCP)\* offers a modern alternative for investors seeking global mobility and secure second citizenship. Through a contribution to the national Treasury Fund, applicants and their families can obtain citizenship while supporting Nauru's economic diversification and climate adaptation projects.

### PROGRAM OVERVIEW

3-4 months to citizenship

Visa-free travel to 90 Countries and Territories

Travel visa-free & visa-on-arrival to 150 countries and territories

Dual citizenship is permitted

Include spouse, dependent children under 30 years of age, dependent parents of the main applicant or spouse

No capital gains tax, inheritance tax, or global income tax

No residency requirements or mandatory visits.





## GENERAL REQUIREMENTS:

- Main applicant must be at least 18 years old
- Clean criminal record for all applicants
- Lawful source of funds must be demonstrated
- Application must be submitted via accredited agents, with strict AML/KYC compliance



## INVESTMENT REQUIREMENTS

1. The main applicant must be over 18 years of age.
2. The main applicant and dependents must have a clear background with no criminal record.
3. Applicants must demonstrate a lawful source of funds\* used for the contribution and fees.
4. Applicants from restricted jurisdictions\* (such as sanctioned countries) may only apply if they have legally resided outside their country of origin for more than 5 consecutive years, supported by proof such as a residence permit.
5. All applications must be submitted via licensed and accredited agents, in full compliance with international AML/KYC standards.

## INVESTMENT CRITERIA

### DONATION TO TREASURY FUND (ECRCP)

#### Minimum Investment:

The program requires applicants to make a non-refundable contribution\* to the Nauru Treasury Fund, which supports climate resilience and national development projects.

- Single applicant - \$105,000
- Applicant + up to 3 dependents - \$110,000
- Applicant + 4 or more dependents - \$115,000
- \$15,000 for each sibling of a Principal Applicant or their spouse

## APPLICATION CRITERIA

In addition to the required contribution, applicants must also pay the following fees:

#### APPLICATION FEE:

- \$25,000 (per application)

#### DUE DILIGENCE FEES:

- \$10,000 (main applicant)
- \$7,500 (per dependent above 16 years old)

#### PASSPORT FEE:

- \$500 (per passport issued)

#### BANK DUE DILIGENCE / PROCESSING FEES:

- Approx. \$1,200 for a single applicant (higher for families, depending on the number of dependents)

#### ADDITIONAL DEPENDENTS:

- Specific charges may apply (e.g., \$15,000 for siblings), depending on the dependent category.

#### PROFESSIONAL FEES

- Provided upon request

#### Note:

All application fees by the NAURU government and ELEWAY are subject to change. These fees depend on the number of applicants and the complexity of the process
