SÃO TOMÉ AND PRÍNCIPE CITIZENSHIP BY INVESTMENT

Launched in 2025, São Tomé and Príncipe offers citizenship by investment through a contribution to the National Development Fund, supporting key sectors such as healthcare, education, infrastructure, energy, and eco-tourism. It provides a faster and lower-cost alternative compared to traditional programs in the Caribbean and Europe.

PROGRAM OVERVIEW

2 months to citizenship

Visa-free travel to 70 Countries and Territories

Travel visa-free & visa-on-arrival to 150 countries and territories

Dual citizenship is permitted

Include spouse, dependent children up to the age of 30 years (unmarried), and dependent parents/grandparents up to the age of 55+ in the same application.=

Minimum \$90,000 for a single applicant. Family packages from \$95,000

No residency requirements or mandatory visits.





The Citizenship by Investment (CBI) Program of São Tomé and Príncipe requires applicants to make a contribution to the National Development Fund. In return, subject to due diligence and approval by the competent authorities, applicants and their families are granted full citizenship.

INVESTMENT CRITERIA

DONATION TO THE NATIONAL DEVELOPMENT FUND

Minimum Investment - \$90,000 (Single Applicant)

The investor must make a minimum non-refundable donation based on the number of family members included:

- Single applicant - \$90,000
- Family packages (2-4 members) from \$95,000
- Minimum \$90,000 for a single applicant.
- Additional Dependents - \$10,000

APPLICATION CRITERIA

In addition to the required contribution, applicants must also pay the following fees:

PASSPORT ISSUANCE:

- \$350 per passport

DUE DILIGENCE FEES:

- \$5,000 per adult applicant

GOVERNMENT/PROCESSING FEES

- Certificate of Registration: USD 250 per person
- National ID: USD 150 per person
- Submission Fee: USD 5,000 per application (flat, regardless of family size)

PROFESSIONAL FEES

- Provided upon request

All application fees by the SÃO TOMÉ government and ELEVAY are subject to change. These fees depend on the number of applicants and the complexity of the process
