UNITED STATES OF AMERICA EB5 IMMIGRANT VISA

The USA EB5 Investor Programme seek to attract foreign individuals who will be entitled to obtain the Green Card in a period of approximately 24-30 months, upon investing a minimum of \$800,000 in a U.S. approved project and by fulfilling other requirements.

PROGRAM OVERVIEW

Processing time of 24-30 months.

Include family members in your application. Spouse and dependent children under 21 may be included.

Ability to live, work, and study in the United States. Also able to live in any state without restrictions.

Must reside in the USA for 6 months per year to maintain residency.

Eligible for US citizenship after five years of permanent residency (green card).

OTHER REQUIREMENTS No age, business experience, education or language requirements.





The EB5 program was created by congress in 1990 to stimulate the U.S. economy through job creation and capital investment by foreign investors. In return the investor becomes a lawful permanent resident in the United States.

- No minimum net worth
- No education requirement
- No work experience requirement
- Good health condition and normal intelligence
- No criminal record
- Must pass a drug screening
- Full-time EB-3 job offer required
- Must work for the employer for at least one year
- Applicants aged between 18-50 years old are recommended.

THE UNITED STATES EB5 VISA PROCESS

- Minimum Investment - \$800,000
- Invest no less than \$800,000 in a U.S. approved project located in a targeted employment area
- Applicants have the option of investing individually or as part of a larger investor pool via Regional Centers.
- Directly or indirectly create 10 jobs in the approved project
- May undergo an interview with the immigration officer in the United States.

APPLICATION CRITERIA

In addition to making the requirements outlined, applicants must also pay the following fees:

LEGAL FEE:

- \$80,000 USD per file

PROCESSING FEES:

- At present the USCIS charges \$1,500 submission fee. This cheque will be written directly to the USCIS.
- \$750 will be required for each additional family member applying.

VISA APPLICATION:

- Your I-829 Permanent Visa Application is NOT INCLUDED in this agreement. You will be charged an additional \$5,000 USD to complete this submission when applicable.
